- 1. The Ministry of Health has received funds from Government of Italy. It is intended that part of the proceeds of these grants will be applied to eligible payments under the contract for construction of The CONSTRUCTION, COMPLETION AND MAINTENANCE OF PALESTINE MEDICAL COMPLEX-EMERGENCY -RAMALLAH- PALESTINE .
- 2. Central Tendering Department on behalf of Ministry of Health now invites sealed bids from eligible bidders certified (Third Grade or greater) in (Building ). Contractor certificate must be issued and valid from the National Committee for Contractors Classification.
